CONTRACT AGREEMENT

THIS AGREEMENT made the 19th day of August 2024 between DEPARTMENT OF EDUCATION, SCHOOLS DIVISION OFFICE DAGUPAN CITY of Dagupan City, Pangasinan (hereinafter called "the Entity") of the one part and ICOR ENTERPRISES of Tuliao, Sta. Barbara, Pangasinan (hereinafter called "the Supplier") of the other part;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- In consideration for the sum of Two Million Nine Hundred Seventy-Three Thousand One Hundred Twenty-Three Pesos (Php 2,973,123.00) or such other sums as may be ascertained, ICOR ENTERPRISES agrees to PROCUREMENT OF PRINTING AND DELIVERY OF QUARTER 1 SELF-LEARNING MODULES in accordance with his/her/its Bid.
