

WHEREAS, the Approved Budget for the Contract (ABC) which is funded by the Government of the Philippines (GOP)-General Appropriations Act (GAA) FY 2024 through the Department of Education is Five Million Five Hundred Forty-Eight Thousand Four Hundred Pesos (Php 5, 548, 400.00);

WHEREAS, the BAC through its Secretariat posted the Invitation to Bid at the PhilGEPS portal with Reference No. 10986202, at the Division website and at the conspicuous places of the Division Office on June 1, 2024;

WHEREAS, the Submission and Opening of Bids was held on July 9, 2024 at the 4th Floor, Conference Hall, SDO Dagupan City with TWO (2) bid proposals;

WHEREAS, only ONE bid proposal passed the eligibility requirements after thorough examination of its technical and financial bid documents;

WHEREAS, the Technical Working Group (TWG) conducted a Detailed Bid Evaluation and Post Qualification Evaluation on July 23, 2024 and August 15, 2024 respectively;

WHEREAS, on August 14, 2024 through BAC Resolution No. 2024-0073-A and No. 2024-073-B, the committee adopted and confirmed the TWG Detailed Bid Evaluation Report declaring NUTRIDENSE as the bidder with the Least Calculated and Responsive Bid;

WHEREAS, the committee concluded to declare NUTRIDENSE as the least calculated and most responsive bidder;

CONTRACT AGREEMENT

THIS AGREEMENT made the 14th day of August 2024 between **DEPARTMENT OF EDUCATION, SCHOOLS DIVISION OFFICE DAGUPAN CITY** of Dagupan City, Pangasinan (hereinafter called "the Entity") of the one part and **NUTRIDENSE FOOD MANUFACTURING CORPORATION** of Sta. Barbara, Pangasinan (hereinafter called "the Supplier") of the other part;

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **Five Million Two Hundred Seventy Thousand Nine Hundred Eighty Pesos (Php 5,270,980.00)** or such other sums as may be ascertained, **NUTRIDENSE FOOD MANUFACTURING CORPORATION** agrees to **School-Based Feeding Program-Enhanced Nutribun** in accordance with his/her/its Bid.
