

**WHEREAS, the Approved Budget for the Contract (ABC) which is funded by the Government of the Philippines (GOP)–General Appropriations Act (GAA) FY 2024 through the Department of Education is Two Million Eight Hundred Sixteen Thousand Eight Hundred Eighty Pesos (Php2,816,880.00);**

**WHEREAS, the BAC through its Secretariat posted the Invitation to Bid at the PhilGEPS portal with Reference No. 10986305, at the Division website and at the conspicuous places of the Division Office on June 1, 2024;**

**WHEREAS, the Submission and Opening of Bids was held on July 9, 2024 at the 4th Floor, Conference Hall, SDO Dagupan City with TWO (2) bid proposals;**

**WHEREAS, only ONE bid proposal passed the eligibility requirements after thorough examination of its technical and financial bid documents;**

**CONTRACT AGREEMENT**

THIS AGREEMENT made the 14th day of August 2024 between **DEPARTMENT OF EDUCATION, SCHOOLS DIVISION OFFICE DAGUPAN CITY** of Dagupan City, Pangasinan (hereinafter called "the Entity") of the one part and **NUTRIDENSE FOOD MANUFACTURING CORPORATION** of Sta. Barbara, Pangasinan (hereinafter called "the Supplier") of the other part;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

In consideration for the sum of **Two Million Six Hundred Eighty Eight Thousand Eight Hundred Forty Pesos (Php 2,688,840.00)** or such other sums as may be ascertained, **NUTRIDENSE FOOD MANUFACTURING CORPORATION** agrees to **School-Based Feeding Program- Brown Rice Nutty Fruity Bar** in accordance with his/her/its Bid.
