CONTRACT AGREEMENT

THIS AGREEMENT made the 9th day of September 2024 between **DEPARTMENT OF EDUCATION**, **SCHOOLS DIVISION OFFICE DAGUPAN CITY** of Dagupan City, Pangasinan (hereinafter called "the Entity") of the one part and **V & J Trading** of Plaridel, Bulacan (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly SCHOOL-BASED FEEDING PROGRAM- JUICE DRINK WITH NUTRTIOUS BISCUIT/COOKIES and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Million Five Hundred Seventeen Thousand Two Hundred Sixty-Six Pesos and Forty Centavos (Php 2,517,266.40) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that additional contract</u> <u>documents or information prescribed by the GPPB that are subsequently</u> <u>required for submission after the contract execution, such as the Notice to</u> <u>Proceed, Variation Orders, and Warranty Security, shall likewise form part of</u> <u>the Contract.</u>
- 3. In consideration for the sum of Two Million Five Hundred Seventeen Thousand Two Hundred Sixty-Six Pesos and Forty Centavos (Php 2,517,266.40) or such other sums as may be ascertained, V & J Trading agrees to SCHOOL-BASED FEEDING PROGRAM- JUICE DRINK WITH NUTRTIOUS BISCUIT/COOKIES in accordance with his/her/its Bid.
