This Office interposes no objection, provided that the following conditions are met.


1. Participation is strictly voluntary;

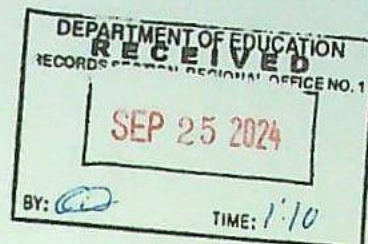

(A Musical about Juan Luna, the first recognized Filipino artist and a political activist of the Philippine revolution).



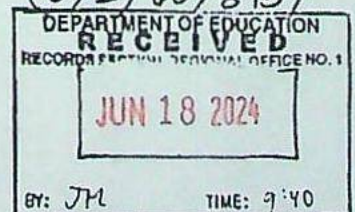

The same law also does not prohibit the act of directly willing to the parents inviting their children to watch your show, subject to the same qualification stated above
