

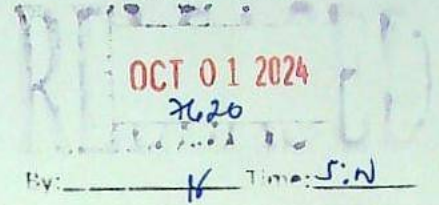

SUBJECT : PARTICIPATION TO THE RIGHTS HOLDER CONSULTATION

1. In line with the various activities for the Development of BSP Safeguarding Policy, we are inviting all the National Scouts Representatives (NSRs) and two (2) Regional Scouts Representatives (RSRs) per region to attend the **Rights Holder Consultation on October 4-5, 2024** at 5th Floor, NEB room, BSP National Office, Manila.
2. The activity aims to gather inputs, comments, and recommendations from Scouts which will be considered and included in the development of BSP Safeguarding Policy.
3. With regards to the airfare of NSRs and RSRs from Visayas and Mindanao, please note that the BSP National Office will facilitate the booking of plane tickets. Kindly fill-out the attached confirmation slip indicating the preferred flights on or before 19 September 2024. Please note, that **minor (a person below 18 years old)** NSRs and RSRs are required to have a company while traveling to the venue either their parent or official guardian.
4. May we request that the Local Councils, to shoulder all travel expenses of parents/guardian.
5. For the Inland travel expenses of RSRs coming from Luzon area, please take note that we have allotted a Php 1,500.00. The amount is subject to reimbursement and depends on the availability of official bus/taxi receipts. For any additional expenses, we request the respective Local Councils of RSRs to cover the cost.
6. Food and accommodation during the activity will be covered by the BSP National Office.
7. With these, all Cluster Heads and/or Deputy Cluster Heads are requested to coordinate with their respective RSRs regarding the activity and other logistics for their participation to the abovementioned activity.
