BASIC TRAINING COURSE FOR KAWAN, TROOP AND OUTFIT ADVISORS

1. The Boy Scouts of the Philippines (BSP) Dagupan City Council in cooperation with the DepEd shall conduct the "Basic Training Course for Kawan Leaders, Troop Leaders, and Outfit Advisors 2024" at Federico N. Ceralde Integrated School (FNCIS) on November 8, 9 and 10, 2024.
2. In line with this, participants to this three (3) day training course are the untrained teachers for Grades 1 to Grade 3 for Kawan (KL), Grades 4 to Grade 6 for Troop Leaders (TL), and Secondary School Teachers for Outfit Advisors (OA).
3. The course will underscore the importance of scouting activities addressing the developmental needs of the scouts, facilitating their engagement in life skills and to promote our council's own course staff.
4. Registration fee is Php1,300.00 to cover expenses for the three day meals, neckerchief, training materials and other miscellaneous expenses.

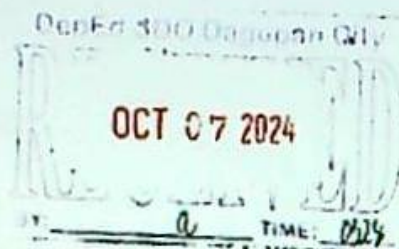

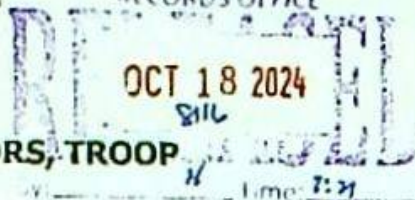

Scouting Activities are provided to our Scouts, and to equip the leaders with much-needed skills, the Dagupan City Council, Boy Scouts of the Philippines, in partnership with the Department of Education-Schools Division of Dagupan City, is pleased to announce the conduct of its Basic Training Course for Outfit Advisors, Troop Leaders, and Kawan Leaders with the following details:

Date: 08-10 November 2024

Participants: Untrained teachers for Grades 1 to Grade 3 for Kawan Leaders, Grades 4 to 6 for Troop Leaders, and Secondary School Teachers for Outfit Advisors.

Registration fee: Each participant will be charged one thousand three hundred pesos (Php 1,300.00) to cover expenses such as neckerchief, meals, and other miscellaneous expenses. The council shall subsidy the meals of the staff who will be serving in the three courses.

3. For purposes of organizing the course staff for the three courses and for the conduct of Course Staff meeting, the deadline for pre-registration will be on October 21, 2024, at 1700 hrs to determine whether we have the required number of participants.






4. Payment for the training will only be accepted after we determine that we have enough participants for the course.
