CONTRACT AGREEMENT

THIS AGREEMENT made the 14th day of November 2024 between **DEPARTMENT OF EDUCATION**, **SCHOOLS DIVISION OFFICE DAGUPAN CITY** of Dagupan City, Pangasinan (hereinafter called "the Entity") of the one part and **ZYNNAH MI TRADING** of Pantal, Dagupan City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly PROCUREMENT OF PRINTING EQUIPMENT AND SUPPLIES FOR DIFFERENT SCHOOLS OF SDO DAGUPAN USING SAVINGS FROM ALLOTMENT PROCUREMENT OF PRINTING EQUIPMENT AND SUPPLIES FOR DIFFERENT SCHOOLS OF SDO DAGUPAN USING SAVINGS FROM ALLOTMENT and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Two Million Seven Hundred Ninety Thousand One Hundred Fifty Pesos (Php 2,790,150.00) (hereinafter called "the Contract Price").

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
