- The activity aims to continuously advocate the implementation of the revised SBM policy guidelines and to showcase noteworthy practices through the launching of the electronic compendium on SBM/SGC.
- 3. Dagupan City National High School (DCNHS), a select school in SDO Dagupan City to showcase noteworthy practices on SBM and SGC, shall prepare poster exhibit for SGC noteworthy practices using two tarpaulins, each measuring 5 feet by 2 feet. In addition, the school is requested to prepare a 2 to 3-minute video presentation and SGC write-up with pictures, which should comprise 10 to 15 pages for inclusion in the compendium.
- 4. The top five (5) schools in the poster exhibit will be officially announced during the convergence. The criteria for evaluation are as follows: Visual Appeal (25%), Completeness of Contents (45%), Accuracy of Poster Content, including spelling, grammar, and punctuation in any text (20%), and Display and Organization (10%).
- 5. The SBM advocacy t-shirt shall be used during the activity.
- Travel expenses and accommodation of the participants shall be chargeable against division/school funds to the existing accounting and auditing rules and regulations
- Immediate dissemination of this Memorandum is desired.


