1. As per DepEd Memorandum No. 063, s. 2024 titled **"2024 Accreditation and Equivalency Test Registration and Administration Guidelines"**, the Department of Education (DepEd), through the Bureau of Education Assessment (BEA) in coordination with the Bureau of Alternative Education (BAE), announces the registration period for and administration of the 2024 Accreditation and Equivalency (A&E) Test.

2. Pursuant to DepEd Order (DO) No. 55, s. 2016, titled **"Policy Guidelines on the National Assessment of Student Learning for the K to 12 Basic Education Program"**, the A&E Test aims to measure the competencies and life skills of those who have not attended or finished formal elementary or secondary education. This assessment shall allow the learners to obtain certification of completion at different exits in Basic Education, which may be used to access further education, job promotion, entry to job training, and employment.


