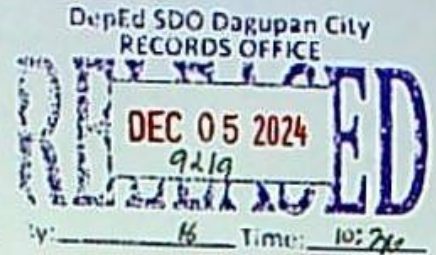

MONITORING OF THE CONDUCT OF SECOND QUARTER EXAMINATION

To: Assistant Schools Division Superintendent

1. In reference to **Division Memorandum No. 492, s. 2024** titled "*Rescheduling of Quarter 2 Examination SY 2024-2025*", this Office announces the Quarter 2 Examination scheduled on December 12-13, 2024 (Thursday & Friday). Consequently, the Parent-Teacher Conference and Distribution of Report Cards will be held on December 14, 2024 (Saturday).

2. This is also to reiterate the **Regional Policy on the Administration of Quarterly Examinations in Public Schools through Regional Order No. 1, s. 2017** which states the following:

- The quarterly examination measures whether learners have met the content and performance standards at the end of a period of learning. That in order for assessment to be more meaningful and authentic, teachers must use methods to measure student learning to assess how well students have learned and have been able to apply their learning in different contexts;
- Only teacher-made test shall be administered to the learners, not test constructed by assigned group in the division;
- The results of the assessment test are recorded and used to report the learner's achievements; The same is primarily reported to the learners and to the parents/guardians; and
- Quarterly examinations shall be monitored by the Regional and Division teams.

3. The Office directs all Chief Education Supervisors, EPSs, PSDSs, and SGOD Personnel to monitor the conduct of the Second Quarter Examination and submit a *District Consolidated Monitoring Report* to the (SMME) Unit of the SDO for consolidation and submission on or before **December 20, 2024**. The report should consist of, among others, the general conduct of the Second Quarter Examination, manner of reproduction of test materials, involvement of teachers in the preparation of the test.
