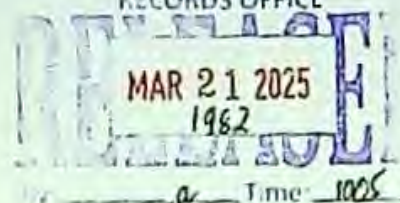

**DIVISION MEMORANDUM**

**OMNIBUS CERTIFICATION on the DESIGNATION OF SCHOOL  
DISASTER RISK REDUCTION and MANAGEMENT COORDINATORS  
and ALTERNATES**

To: Assistant Schools Division Superintendent  
Chief Education Supervisors, SGOD & CID  
Public Schools District Supervisors  
All Public School Heads  
Division Disaster Risk Reduction and Management Coordinator  
All School DRRM Coordinators and Alternates

1. Pursuant to the Department of Education Order No. 21, series of 2015, titled "Disaster Risk Reduction and Management Coordination and Information Protocol," the School Head is designated as the School Disaster Risk Reduction and Management Coordinator (SDRRMC) but is required to appoint an alternate from among the school personnel. Additionally, in accordance with DepEd Order No. 002, series of 2024 titled, "Immediate Removal of Administrative Tasks of Public School Teachers," the assignment PDO I, AO II, and Non-Teaching Personnel as School Disaster Risk Reduction and Management Coordinators (SDRRMCs) is mandatory For schools lacking non-teaching personnel, previous SDRRMCs will retain their positions.
2. This formally certifies the designation of the School Disaster Risk Reduction and Management Coordinators and their alternates. Certificates of designation will be issued immediately upon approval and will remain valid for five (5) years from the date of signing, or until terminated.
3. The Disaster Risk Reduction and Management program comprises twenty-three (23) training modules that are essential for the effective performance of SDRRMCs. It is imperative to note that School DRRM Coordinators will not Be able to complete all required training modules if limited to three (3) years or less.





4. Training of SDRRM Coordinators will cover critical areas, including but not limited to:
  - Protection of Schools
  - Conflict-Sensitive Education
  - Supplies and Logistics
  - Comprehensive DRRM Education
  - Contingency Plan
  - Basic Education Skills in First Aid
  - Cardiopulmonary Resuscitation (CPR)
  - Basic Firefighting Skills and Drills
  - Rescue Operations
  - Psychological First Aid
  - Rapid Assessment of Damage Report (RADaR)
  - Post-Disaster Needs Assessment (PDNA)
  - Camp Management
  - Education in Emergencies
  - Climate Change Adaptation
  - Student Led-Watching and Hazard Mapping
  - Additional training from partner agencies
5. The appointment of an Alternate Coordinator is essential for ensuring continuous training and effective succession planning following the term of the designated School DRRM Coordinator.




