

- Pursuant to Section 43 of Article IV of Republic Act No. 9165 otherwise known as the Comprehensive Dangerous Drugs Act 2002 and based on DepEd Memorandum 200, s. 2016, the Department of Education reiterates its support in Strengthening the National Drug Education Program (NDEP).

5. Criteria for Best National Drug Education Program Implementers is as follows:

	CRITERIA	DESCRIPTION	WEIGHT
1.	Implementation of Instruction / Modules	Effective integration of drug prevention modules and instructions in the curriculum aligned with DAPC week and IDADAIT calendar activities.	12%
2.	Information Dissemination Campaign	Conducting activities to raise awareness through mass media (print, TV, radio) films, slide deck presentation, exhibits, NDEP corners, PDE signage, IEC materials, etc.	12%
3.	Functionality of Barkada Kontra Droga (BKD) Program	Active implementation of BKD activities, including adherence to scheduled activities and scope of school-wide implementation	10%
4.	Community Involvement and Partnership	Collaboration with stakeholders such as parents, civic, religious, government, and non-government organizations in drug prevention activities.	11%
5.	Stakeholders' Engagement and Support	Level of leadership, support, and active participation of learners, teachers, school administrators, PTA, socio-civic/religious groups, government agencies and NGOs	25% (A. Learners 4%, B. Teachers 4%, C. School Admin 4%, D.PTA 4%, E. Socio Civic/ Religious 3%, F. Gov. Agencies 3%, G. NGOs 3%
6.	Provision of Guidance and Counselling Services	Delivery of peer counselling, guidance, and referral services to learners	10%
7.	Learning and Development Activities	Conducting activities aimed at raising stakeholder awareness about drug use prevention	10%
8.		Timely and comprehensive submission of NDEP monthly reports documenting activities and progress.	10%
