- Declaration of Availability and Willingness a signed statement confirming availability to attend training sessions during vacation (for teachers only)
- d. Medical Certificate (issued by a government physician, certifying the participant's physical fitness and emotional stability)
- 4. Participants' board and lodging shall be charged against the Human Resource Development (HRD) Funds. Travel expenses of participants shall be charged against downloaded 2025 HRD Continuing Fund. In case downloaded funds are insufficient, it can be charged to the SDO/School MOOE or local funds subject to usual accounting and auditing rules and regulations.
- 5. Service Credits or Compensatory Time-Off (CTO) shall be granted to participants if the activity falls on weekends, holiday, or cancellation or suspension of classes and work in Government Offices due to typhoon, flooding, and other weather disturbances and calamities pursuant to the guidelines specified in DepEd Order No. 53, s. 2003 on the Updated Guidelines on Grant of Vacation Service Credits to Teachers and CSC-DBM Joint Circular No. 2, s, 2004 on Non-Monetary Remuneration for Overtime Services Rendered, whichever is applicable.
