SCHOOLS DIVISION OFFICES (SDOs)**

1. All public elementary and secondary schools shall establish School Governance Councils (SGCs), which shall serve as overarching consultative and coordinating bodies for all committees, associations, and organizations in their respective schools. The SGC shall form part of the school structure as an embodiment of the principle of shared governance, mandated under Republic Act No. 9155.
2. Relative to this, the Bureau of Human Resource and Organization Development - School Effectiveness Division (BHROD-SED) is in the process of updating the SGC Composite Team directory in the SDOs to ensure that they have the most current contact information and facilitate the provision of Technical Assistance.
