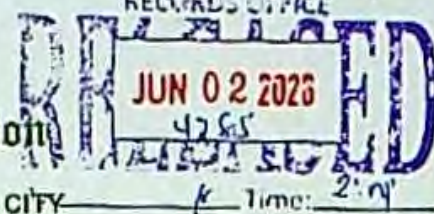

1. The Schools Division Office of Dagupan City, in partnership with the City Government of Dagupan, will conduct a leadership training program entitled *Manlingkor Ya Kalangweran 2026*, wherein selected youth leaders will serve as young counterparts of the City Officials and Department Heads on June 15-22, 2026. These youth officials will be selected from among learners enrolled in the public and private secondary schools of Dagupan City.
2. In line with this, the following public and private secondary schools are requested to send the designated number of Grade 9 learner-participants to undergo leadership training, which shall serve as a prerequisite for their appointment to a position. The learner-participants may or may not belong to the top two learners in their respective classes, provided that they demonstrate leadership potential. Furthermore, the learner-participants must be **BORN IN DAGUPAN and BONAFIDE RESIDENTS OF DAGUPAN CITY**. The training will commence on **June 12-14, 2026** and will be held at the **Division Training Center**.


