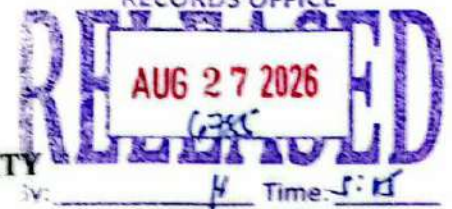

Subject: **ADVANCEMENT SEMINAR WORKSHOP**

1. In line with the 2026 Performance Evaluation Scorecard of the Boy Scouts of the Philippines where both local councils and regional coordinating offices shall deliver 20% of their registered scouts should be advanced in the next higher rank, we are pleased to announce the conduct of the Regional Advancement Seminar Workshop.
2. These seminar-workshops will be held on 30-31 August 2026 to be hosted by Dagupan City Council & 26-27 September 2026 to be hosted by the Ilocos Norte-Laoag City Council.
3. The seminar workshop is open to all Outfit Advisors and Circle Managers who are actively implementing advancement in their units.
4. We will only accept fifty (50) participants for both seminar-workshops. The first workshop is intended for the Councils in Pangasinan while the second workshop is for the councils of La Union, Ilocos Sur and Ilocos Norte. However, institutions from La Union Council who are close to Pangasinan may attend the seminar workshop in Dagupan City. A slot of ten (10) is only open for La Union while Dagupan City shall have ten, fifteen for Eastern Pangasinan Council and Pangasinan-San Carlos City Council respectively.
5. Reports on Advancement, Merit Badge Application Forms (downloadable at BSP Website shall be brought by the participants) for their references and practicum.
6. No registration shall be collected; however councils may extend meal expense to their participants. A small amount shall be shared for the utilities in the venue of accommodation to be shared by the councils participating.
7. All attendees are requested to report to Dagupan City Council Office for registration and monitoring of room sharing. Opening program will commence at 0900hrs.
8. Venue for the Ilocos Norte-Laoag City Council shall be announced later.
9. Widest dissemination of this memorandum is hereby enjoined.
