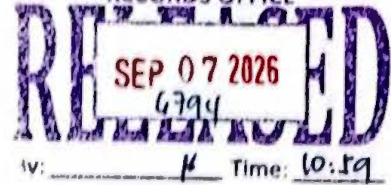

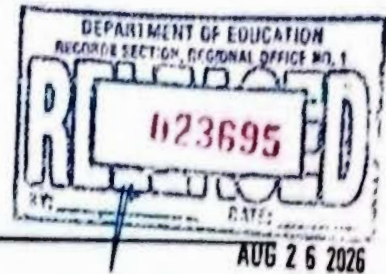

**UPDATED ASSIGNMENT OF QUALITY ASSURANCE DIVISION (QAD)
