1. In reference to the attached **Regional Memorandum No. 1103, s. 2026**, dated August 27, 2026, entitled "*Dissemination of the List of Private Basic Education Institutions (PBEIs) Granted Automatic Recognition for the Senior High School (SHS) Program*," this Office, through the School Governance and Operations Division (SGOD), hereby disseminates the list of Private Basic Education Institutions (PBEIs) granted **Automatic Government Recognition** for the **Senior High School (SHS) Program** effective **School Year 2026-2027**.

2. The grant of automatic Government Recognition is pursuant to **DepEd Order No. 12, s. 2026**, otherwise known as the "*Government Recognition of Private Basic Education Institutions Offering the Senior High School Program*." The Order provides that private basic education institutions that have demonstrated substantial compliance with the prescribed requirements may be granted automatic Government Recognition for the SHS Program, subject to the applicable provisions and conditions stipulated therein.

3. Based on the aforementioned Regional Memorandum, the automatic grant of Government Recognition covers the following eligible institutions:

- a. Senior High Schools attached to Junior High Schools (JHS) that have undergone PEAC Certification and reached Substantial Compliance or higher; and
- b. Senior High Schools that have undergone PEAC Voluntary Certification and reached Substantial Compliance or higher.
